During January, the Board of Directors commenced planning for 2019 and took the following actions:

Leroy Bussells Memorial Tournament (Rockfish, Puppy Drum and Speckled Trout) November 2-3, 9-10, 16-17

Bonus Rockfish (Rockfish only) December 7-8. 14-15, 21-22

- 3. Named the November member fishing tournament the Leroy Bussells Memorial Tournament in memory of NNAC member Leroy Bussells.
- 4. Approved a \$250 donation to Smith Point Sea Rescue in memory of Leroy Bussells. Smith Point Sea Rescue was actively involved, along with the Coast Guard and state and local marine police, in coordinated search and rescue efforts after Leroy was reported missing.

Membership dues for 2019 (\$30) are due by March 31. The membership renewal form was included with last month's newsletter and is available at the club's website. Now is a good time to recruit family members, friends and neighbors to join the club. The club's expenses are funded primarily through member dues. Sponsors contribute to the gift certificates awarded to the first, second and third place finishers for each species targeted in member fishing tournaments during the year.
